Methods

Kreiner and Kinicki, 2010, stated that commitment is a strong agreement to carry out an activity, whether it is for oneself or for other people in certain groups and organizations. Meanwhile, according to Schermerhorn, Hunt, Osborn and Uhl-Bien, 2011 stated commitment is strong or weak evidence of a person's loyalty to an organization(Wibowo 2012). There are various definitions of commitment from many experts, however, basically they are all the same, that commitment is one of the different traits or principles of each individual, which is usually reflected in the attitudes and behavior of each individual. (Wibowo 2012). That is, commitment can shape one's character in activities, in accordance with the principles including matters of loyalty. Conclusion

Commitment is a simple thing that is very much needed in achieving success, but it is not easy to do. Some of the commitments to achieve success include 1. Commitment to discipline 2. Commitment to learn 3. Commitment to implementing a plan, so that you have a mature plan and are ready to start it.(Indonesia 2011). From this quote, we can interpret that every individual or entrepreneur has the right to have their own commitments and apply them in each of their activities, where these commitments influence their decisions in establishing policies, vision, missions and strategies to be used as an effort to achieve the success they expect.

If the two parties fully synergize together, then the company's success in developing, advancing and maintaining the continuity of the company can truly be realized optimally.

Success is a long step that must be taken, even though there is a possibility of losing or winning, but most importantly, one must be persistent in facing competition and tests that come and go, because with a strong commitment, there is a sense of full responsibility in trying to do everything the best and there is a sense of moral responsibility that encourages him to be able to fight as hard as he can for the achievement of goals. This is in line with the article written by Dewi and Burhan which states that commitment is a firm determination to carry out activities with full responsibility to achieve the expected goals. Entrepreneurs can achieve targeted goals based on their high commitment, because this encourages entrepreneurs to carry out their obligations and responsibilities in running a business, so that they can continue to progress and develop. (Purwaningsih dan Burhanudin 2021).

In general, with the principle of their commitment, entrepreneurs try to do the best managerially possible to achieve goals according to the vision, mission and strategy set, even though the commitment of each entrepreneur is different, what is certain is that whatever commitment you have will have an impact on the development, progress and continuity of a business. In running a business, according to the observations of researchers, entrepreneurs generally go through 3 stages, namely, the first or initial stage which is commonly called the start-up stage, where, at this stage, the steps feel very heavy in activities/operations, the second stage or the development stage, namely the process of growing and developing, where all personnel must focus, earnestly go through the process, even though it still feels heavy it still has to be faced, so that the business grows and develops as expected, then the third stage or the maturity stage, where at this stage maturity is

needed in making decisions and the best policies for the best results, because it is at this maturity stage that entrepreneurs can expand the development of their business progress, so that they are able to maintain their position in maintaining the business so that it continues to exist, along with increasing support from aspects of more experience, relationships, insights and improving the quality of capabilities and expertise in their fields, so that at this stage, Companies must be able to be more creative and innovative in running and maintaining their business in order to continue to win fair business competition, still have loval customers and continue to run a business with high productivity so that it continues to exist until the peak of the targeted success.

Maintain maximum harmony of relationships with customers and suppliers, through honesty and openness, so that if problems are found, the best solutions can be found, and through closely intertwined relationships will support the smooth implementation of all activities carried out. 3. Don't get bored to keep learning, be creative and innovative, by continuously improving and improving the quality of the goods/services it produces, easily adapting to the development of the times so that it is strong in facing various obstacles that come its wav.

On the first point, it is same with the principle of HR management, namely only recruiting people who meet the qualifications to be able to join the company, namely the right man on the right job, that as long as the task is entrusted to the right people and according to their abilities, the results of work optimally provided. Meanwhile, according to Cushway, 1994 in Priyono, it is said that HRM is 'Part of the process that helps the organization achieve its objectives'. Which means Human Resource Management as 'part of the process that helps the organization achieve its goals.(Priyono 2010).

From that quote, we can interpret that through human resource management everything can be predicted and tried to be in the best possible condition, because HR is a company asset that plays an important role and can lead a company to success or failure, that's why in implementing HRM this cannot be done simply, Of course, because it has a big influence on the smooth running and success of a company.

The second point is maintaining harmonious relationships with all, one of which can be proven by a harmonious relationship between employers and employees, this will have a positive impact on business continuity for the long term, with a beautiful relationship, making all employees live and feel at work, thereby encouraging them joy in carrying out the task to the fullest. In fact, the workplace can be likened to our second home, because we spend a lot of time at work and/in our work environment, so

it is really necessary to have a harmonious relationship that is established, so that work performance can be good, work productivity is high and output results can be optimal. in terms of quality and quantity, and this condition can be created with good and warm relations from all lines both vertically, horizontally and diagonally, and this will really help the company to continue to exist operationally for a long time.

Mia, 2019, supports harmonious relationships, where, according to her, work relationships are very important in building a career and achieving satisfaction in carrying out every task in the job, that by continuing to make maximum efforts, you will be able to develop positive working relationships, through attitudes good things, such as listening to coworkers, communicating openly, respecting yourself and coworkers.(Dinisari 2019). This means that harmonious relationships must be sought & created, because harmony cannot grow by itself, but there must be harmony in a healthy relationship.

In reality, there are many ways that can be done by companies in fostering good relations with employees and colleagues, one of which is the moment of fostering good relations inside and outside the office, for example by inviting all company personnel to take a vacation together, information disclosure and communication 2 effective direction in all divisions can foster intense good relations within the company, because the more comfortable it is in carrying out its duties, the higher productivity will be created, the more output produced and of high quality, including the marketing sector and all business operations will run smoothly and all strive with joy to achieve success together.

The third point is to keep learning, being creative and innovative, with an attitude of never stopping learning to improve self-quality and getting used to being creative and innovative, so that companies are able to expand their business with a wider market share, are able to produce output with various variants and large quantities. more, including in it, all personnel as a whole continue to try to serve customers optimally, among others, through the availability of more adequate facilities, infrastructure

and facilities that can add to the comfort of all parties involved.

Entrepreneurs who are highly committed, will always be creative, innovative and adaptive in every situation that makes them tough and able to carry their company through a tireless process to continue to strive optimally to achieve the expected success. In line with Helmiatin's opinion which states, an entrepreneurial success is influenced by three things, namely 1. Hard work and perseverance, because with seriousness, hard work and perseverance, will support a person to achieve his goals, 2. Mental all out attitude. Forming a person to be persistent and not easily give up under circumstances, especially in the early years of business standing. 3. Innovative and creative. by creating interesting new ideas in developing their business, so that they are easily adaptive to keep up with market developments by creating products/services that suit the needs and demand of the market.(Helmiatin dan Mulyana n.d.).

Entrepreneur is someone with a creative and innovative spirit and ability, he is able to create something new and different (ability to create the new and different), able to start a business (start up), able to make something new (creative), able to seek opportunities (opportunity) dare to bear the risk (risk bearing) and able to develop ideas and manage the resources they have. (Soegoto 2014a). That is, if a person has these characteristics that are said by Mr. Eddy in his book entitled Entrepreneurship: being an accomplished businessman, then that person has an entrepreneurial spirit that should be confident to carry out his role to be a true entrepreneur who is ready to face anything to achieve future success, because an entrepreneur is someone who has his own business, opens jobs for other people and employs them by providing payment in the form of a salary or wages according to the agreement / agreement of both parties. Whether it's a small, medium or large business, if someone becomes the owner/leader of a business, then he can be called an entrepreneur.

Itturioz, et all 2014, said that Commitment is a business that arises from an entrepreneur and according to Ciasullo & Troisi, 2013, re-

garding Commitment, is the abundance of experience that has been passed / felt and the high level of education taken, will affect the formation of a commitment within oneself someone. (Rahayu 2018).

From the two opinions above, it can be interpreted that the strength or weakness of a commitment is influenced by many factors, but the most important thing is that commitment can be a strong foundation for persistently striving to achieve the expected goals. and this, in line with the book written by Prof. Wibowo, that someone will pay full attention and seriousness to his work performance (if there is no pressure when accepting an agreement), (Wibowo 2017). meaning, shows that someone who has a strong commitment will do all his duties and obligations with joy without feeling forced and with passion to do and give the best results in every activity it does.

In operating his business, every entrepreneur/company must have stumbled upon problems, failed as well, such as failing to achieve set targets, failing to produce output according to orders so that it was rejected and returned by customers or not accepted by the market, and so on. However, all of this does not mean that entrepreneurs stop learning to improve and improve their quality, trying to be active, more creative and innovative looking for various solutions so that their business continues to run conducively, can develop and be more advanced, and certainly, to achieve the dream of success. then every entrepreneur must have a strong commitment in operating his business, by staying focused on the choice of business he wants to run, consistently managing his business operations to the best standard, always maintaining trust, good name, promises that have been made, maintaining customer loyalty, continuing to be disciplined in carry out all of its activities, and continue to be determined to develop and advance the company to become even bigger all the time.

Commitment is a strong foundation for someone to achieve success, as well as for entrepreneurs, if the commitment is as strong as steel, it will encourage burning enthusiasm and effort in carrying out every business, and success is very likely to be realized optimally, from there it can be seen that there is a close

Practical Implications

It is hoped, with this research will be able to open insights for all of us, that the Indonesian state can definitely progress, if there are more and more entrepreneurs and all parties work together well, moreover, we have abundant natural wealth, but we cannot fully utilize it optimally, even though, we should be able to do better in managing existing wealth wisely, because there are many ways to be creative and innovative to achieve success.

This study explains the struggles of entrepreneurs in general or in outline, in implementing their commitment to achieve the expected goals/success, in several ways that are usually often applied in various business sectors, so that, it can give an illustration, that with a strong commitment and seriousness of effort in every activity done, can support entrepreneurs to be more productive in operating their businesses, so that entrepreneurs and their companies can make a greater contribution to the improvement of our nation's economy.
